THE ELECTRONIC AND POSTAL COMMUNICATIONS (ELECTRONIC COMMUNICATION NUMBERING AND ADDRESSING) (AMENDMENT) REGULATIONS, 2020

Citation

GN. No. 62 of 2018 1. These Regulations may be cited as the Electronic and Postal Communications (Electronic Communication Numbering and Addressing) (Amendment) Regulations, 2020 and shall be read as one with the Electronic and Postal Communications (Electronic Communication Numbering and Addressing) Regulations, 2018 hereinafter referred to as the "principal Regulations".

Amendment of regulation

2. The principal Regulations are amended in regulation 2 by deleting the words "dot-tz".

Amendment of regulation 3

by -

- **3**. The principal Regulations are amended in regulation 3
- (a) deleting the definitions of the words "accredited registrar", "database manager", "tzNIC", and tzccTLD";and
- (b) deleting the words "addresses under dot-tz country code Top Level Domain also known in its acronym as ccTLD" appearing in the definition of the word "electronic address" and substituting it with the words "IP Addresses".

Deletion of regulation 10

4. The principal Regulations are amended by deleting regulation 10 and substituting for it the following-

Calling Line Identification

- **10**. A licensee shall have the following obligations with respect to Calling Identification presentation:
 - (a) provide Calling Line Identification (CLI) Facilities, and enable them by default, unless they can demonstrate that it is not technically feasible viable to do so in order to ensure that recipients call can identify the person calling them and choose whether or not to accept the call;
 - (b) ensure that a CLI data which provides for or associated with a call, has a valid, routable
 - telephone number which uniquely identifies the caller;
 - (c) take all reasonable steps to identify calls, other than calls to life and safety numbers, in relation to which invalid or non-routable CLI Data is provided and prevent those calls from being connected to the called party where such calls are identified;
 - (d) for SMS delivery where the SMS sender is identified by a number without name, the name shall include information that identifies the sender.

GN NO. 938 (Conted) Amendment of regulation 11 by -

- 5. The principal Regulations are amended in regulation
- (a) deleting the marginal note and substituting for it the following "Obligations of entities";
- (b) deleting the words "monthly basis" appearing in subregulation (1) and substituting for them the words "bi-annually January and July";
- (c) deleting the words "and registered domain names" appearing in subregulation (2);
- (d) deleting subregulations (3).

Amendment of regulation 13

6. The principal Regulations are amended in Regulation

- (a) designating regulation 13(1) as regulation 13; and
- (b) deleting subregulation (2).
